Ref: CSO's letter no 5403/ dt 27-06-2016

Sir,

In Reference to the above subject I am to submit that CSO has sent names of 134 ineligible persons to lodge FIR against them under NFSA-13, for obtaining ration card illegally. Out of which no specific reasons is mentioned against 25 beneficiaries regarding their ineligibility. It is simply mentioned that they have not turned up to receive the stocks for more than three months and above. It is not a valid ground to file FIR without specific reason i.e. whether they are coming under 9 exclusion criteria under NFSA-13 or not. In this condition their cards may be cancelled for not receiving stocks more than three months but for lodging FIR specific reasons as above to be mentioned.

Therefore specific instructions may be given in this regard. Further we are lodging FIR against the rest ineligible beneficiaries mentioned in the list.

Sir,

I am directed to say that the following beneficiaries as mentioned below have availed ration cards under National Food Security Act-2013 although they are coming under nine exclusion criteria provided by the Government as communicated by CSO, Cuttack in his letter No.5345 dated 24.06.2016 (copy enclosed). They have violated the Clause-29 of OPDS (Control) Order, 2016 quoted below with ill intension to misappropriate public money.

29. Penal Provisions for Fraud by Ineligible Beneficiaries

(1) If any person coming under the exclusion criteria notified by the State Government obtains a ration card by providing false information, the following action shall be initiated against such person, namely:

- Criminal proceeding will be initiated;
- The market cost of the food grains taken by such person shall be recovered from him/her as an arrear of land revenue with 10% rate of interest per annum from the date of receipt of the subsidized food grain.
- In case of employees of Government or Corporation or PSU, Departmental Proceeding shall be initiated against such employees.

This may please be treated as FIR to initiate criminal action against them.
