4. Thickness-120 Micron

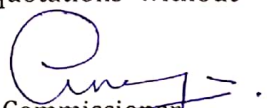
The Bidders shall submit the bill for **unit price of both Sticker paper type at Sl. no 03** along with the bid documents.

- The bidders, who have been disqualified by CMC, State Govt., PSU, Central Govt. are not eligible to apply

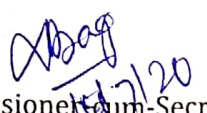
