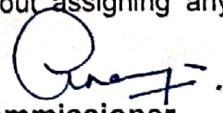

2. Attested Xerox Copy of PAN/ITCC.
3. EMD @ 1% of the quoted value, in shape of Demand Draft/Pay order, Drawn in favour of Municipal Commissioner, Cuttack Municipal Corporation, from any Nationalized Bank.
4. Tender paper Cost of Rs. 600/-+ GST as applicable (Non Refundable) in shape of Demand Draft/Pay order drawn in favour of Municipal Commissioner, Cuttack Municipal Corporation Cuttack from any Nationalized Bank.
5. A letter of Authorization form the Manufacture is to be submitted, in case of Suppliers.

Other Requirements

- The Bidders shall submit the bid documents in the prescribed schedule, through Regd. Post/Speed Post/courier services only, to the Commissioner, Cuttack Municipal Corporation, Choudhury Bazar, Cuttack-9.

- The bidders have to deposit samples of each quoted item as per specification in sealed packets, to the Health Officer, Cuttack Municipal Corporation, Cuttack at the time of submission of bid document, for verification before the time of opening of the tender, otherwise the bids shall not be considered.

- The Bidder to deliver Biomedical Waste Bags within 24 hour receipt of work order.

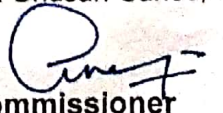

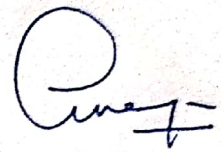
