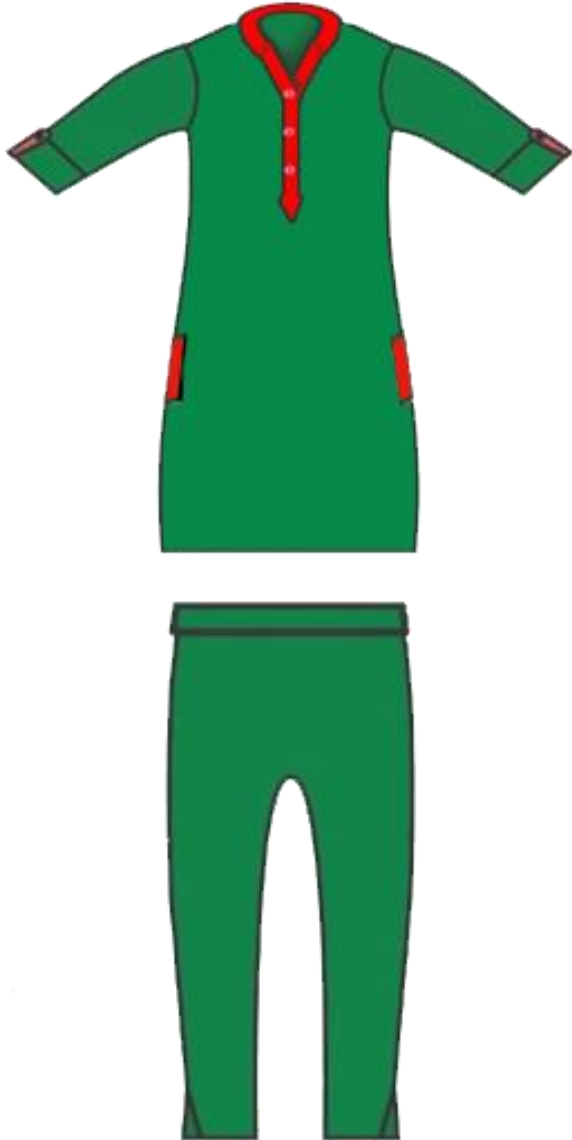


Why uniforms ?

Top

- Colour: Bottle Green with red strips
- Short kurta
- 3/4th sleeve with red piping (Roll up with bottom up)
- Mandarin neck design with buttons
- Two side kurta pocket (with red strip) attached to side slit

Kurta length – 32 inch

Pant

- Straight cut
- Bottom side slit
