In exercise of power conferred through Cuttack Municipal Corporation Solid Waste Management Bye-law, 2017 vide Clause No.12 (2) in Chapter – 'x', the CMC Council confirms the recommendation of License & Standing Committee in its meeting dtd.24.03.2023 (Recommendation No.8, Annexure-2), regarding modification of Users Charges as per enclosed Schedule-I list in its 12th Council meeting on 12.04.2023.

The revised rate of User Charges will be effective from 1st April, 2023.

In case of payment of User Charges in advance for the entire year by 31st May of current financial year, then amount for 11 (Eleven) months will be charged instead of 12 (Twelve) months.

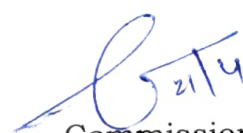
