Sealed Quotations are invited from interested Agencies/NGO/Caterer/Food Business Operators/Individuals, for supplying diet for dogs under Animal Birth Control Programme, which shall reach the Commissioner, CMC, Choudhuary Bazar, Cuttack on or before **29.10.2025 at 5.00 p.m.** through **register post or speed post**. The Tender documents can be downloaded from CMC official web site (www.cmccuttack.gov.in) with effect from **13.10.2025 at 4.00 p.m. to 29.10.2025 at 5.00 p.m.** The tender will open on **dt. 30.10.2025 at 12.00 p.m.** at the Chamber of Health Officer, CMC Bikash Bhawan, Badambadi, Cuttack.

Terms &Condition :

1. The term of the contract shall be for one year, this may be extended depending open the satisfactory performance of the contractor.
2. Diet for adult dogs are to be supplied at dog yard (Sartol), having a maximum capacity of 125 kennels.
3. Diet is to be supplied twice in a day for 7 days (including day of catching & day of release) and Biscuit & Milk at Morning timeas per scheduled in the tender.

The number of dogs shall vary from day to day & the diet is to be supplied as per the actual number of dogs available on the particular day, which shall be intimated by the dog yard supervisor at 9 p.m. everyday.

4. The Maximum Budget for diet permissible is @ Rs. 100/- (Rupees Hundred) Only for each dog per day including breakfast, lunch & dinner.
5. The diet is to be prepared fresh, before it is being served. It should be served in cleaned utensil, by the contractor.
6. The details of food to be supplied & its nutritional value & weight of individual food items are to be submitted in the quotation in the attached schedule-"A".
7. Supplier may be allowed to prepare the food inside the campus at Sartol, with due prior permission of the Municipal Authority.

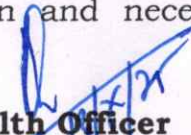

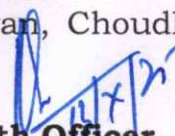

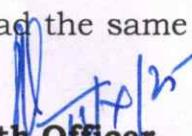
