If the office happens to be closed on the date of receipt / opening of Quotation as specified the quotation.
- iii. **Quotation Paper Cost** – The prescribed Quotation schedule can be obtained from Cuttack Municipal Corporation during office hours except holidays on payment of Rs. 4720/- (Rupees Four Thousands Seven Hundred Twenty) only in shape of Cash (Non refundable).
